R.No. 4. The Gramsabha meeting of Afenda village Panchayat discussed over the notification announcing that S.C.Z.M.A has decided to hold a public hearing for the entire South Goa District on 2 nd March 2021 at Rawindra Bhawan, Margao from 10 AM to 7 P.M. The Gramsabha also saw the over camp maps sent to V.P. Afenda for the coastal areas of the village of Afenda. It was observed and agreed that:	
1. The New maps and legends need to be explained to all the affected villagers. It is therefore most essential that S.C.Z.M.A. depute a knowledgeable person to the Panchayat to explain the camps to the people during a Gramsabha meeting before holding a public hearing.	
2. The public hearing scheduled on 2 nd March 2021 is not feasible for the following reasons:	
a. Afenda villagers who are affected by the C.Z.M.P. are interested in protecting the village and the highly vulnerable and most precious C.Z.M. Areas. Therefore the villagers can effectively participate only if a public hearing is held for the village exclusively within the Panchayat Area.
